Description and Mission

This course examines the interactions of religion, law, and society, primarily through an examination of legal codes and manuals of conduct of religious associations. While reading these texts, students are expected to consider the following: How is membership in a group established? How is a community constituted internally, and in relation to the surrounding society? What tensions exist between an individual and a group, and what strategies are used to diffuse them? What is the relationship of the individual to his religious community and to God, and in what ways are these two relationships similar and distinct from one another?

In addition to an exploration of laws of religious orders, the course examines laws governing religion and society in ancient societies that are broader than small religious associations. These examples, from ancient China and ancient Greece, will allow to further consider the distinction between laws of an association, a guild, or a monastery, from the structure of a broader society, and the way religion and law functions in these different settings.

The course deploys a comparative approach. Students are expected to develop tools for comparison, first and foremost by placing each work in its particular historical and cultural context. Questions of comparisons between different readings will take into consideration the differences between their contexts, and will address the cause or the implication of the similarity.

Grading

Students who enter class late will be asked to leave the course.

Students are expected to come to class having prepared the readings (consult separate document on preparation), and with questions and insights for discussion. Class will focus on discussion of the readings.

The written assignment is a final research paper, to be submitted by Sunday, June 9, 2019, at 9pm. Students should consult assignments sheets for further instructions.
